Invitation to Bid for the Construction of DILG Quirino Provincial Office

- 1. The DILG Regional Office 2, through the General Appropriations Act (GAA), FY 2021 intends to apply the sum of six million nine hundred fifty thousand nine hundred ninety-nine pesos and eighty-four centavos (Php 6,950,999.84) being the Approved Budget for the Contract (ABC) to payments under the contract for Construction of the DILG Quirino Provincial Office with Project Identification 2021-02-067. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The DILG Regional Office 2 now invites bids for the Construction of the DILG Quirino Provincial Office to be constructed at Provincial Capitol Compound, Cabarroguis, Quirino. Completion of the Works is required within 210 calendar days upon receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from the *DILG Regional Office 2 BAC Secretariat* and inspect the Bidding Documents at the address given below *during office hours from 8:00 AM 5:00 PM*.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on March 15, 2021 from given address below and upon payment of the non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos (Php 10,000.00) only. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.

The DILG Regional Office 2 will hold a Pre-Bid Conference¹ on March 24, 2021 at 10:00 AM to be held at the Conference Hall, DILG Regional Office 2, Carig Sur, Tuguegarao City, Cagayan Valley and through videoconferencing via Zoom (for registration, please send your request to email address r2dilg@yahoo.com on or before March 23, 2021, 12:00 NN) which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat through manual submission at the
office address as indicated below on or before April 5, 2021 at 10:00 AM. Late bids
shall not be accepted.

May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

- 7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 8. Bid opening shall be on April 5, 2021 at 1:00 PM at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 9. The DILG Regional Office 2 reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
