Bidders should have completed, within 3 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from **Department of the Interior** and Local Government Region II and inspect the Bidding Documents at the address given below during 8:00 in the morning until 5:00 in the afternoon; Monday to Friday.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on 6th day of November, 2020 from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the amount stated in the IB No. 2. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- 6. The **Department of the Interior and Local Government Region II** will hold a Pre-Bid Conference on **13th day of November, 2020 10:00 in the morning** at DILG Region II Conference Hall, Regional Government Center, Carig Sur, Tuguegarao City, Cagayan which shall be open to prospective bidders.





- 7. Bids must be duly received by the BAC Secretariat through **manual submission** at the office address indicated below on or before 25th day of November, 2020 at 10:00 in the morning. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on **25th day of November, 2020** at exactly 1:00 in the afternoon at the given address below. Bids will be opened in the presence of the bidder's representatives who choose to attend the activity.
- 10. The **Department of the Interior and Local Government Region II** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
