### INVITATION FOR NEGOTIATED PROCUREMENT DUE TO TWO-FAILED BIDDINGS

## PROCUREMENT OF SERVICE VEHICLE

- 1. The Department of the Interior and Local Government Regional Office 2 (DILG R2), through the General Appropriations Act Fund 101 FY 2022, intends to apply the sum of One Million Four-Hundred Fifty Thousand Pesos (P1,450,000.00) being the ABC to payments under the contract Procurement of Service Vehicle with Project Identification Number 2022-03-133.
- 2. The DILG R2 now invites bids for the above Procurement Project. Delivery of the Goods is required within thirty (30) calendar days upon Supplier's receipt of the Notice to Proceed. Bidders should have completed, within three (3) years (July 2018 to July 2021) from the date of submission and receipt of bids, a contract similar to the Project. For this purpose, similar contracts shall refer to Supply and Delivery of (Multi-Purpose Vehicle), Brand New, 7-10 seater, air-conditioned, Diesel/Gas, A/T.

Pursuant to Budget Circular No. 2022-01 dated February 11, 2022, Multi-Purpose Vehicle (MPV) is a four-wheel enclosed vehicle having dual side doors and a fifth rear door or lift-up tailgate. It has a maximum seating capacity of 10 passengers, including the driver, with two (2) rows of front seats and foldable rear seats (optional). Engine displacement not exceeding 2500 cc for gasoline or 2800 cc for diesel; or AFV.

3. Bidding will be conducted through Negotiated Procurement bidding procedures pursuant to Section 53.1 of 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, including Annex H thereof.

The BAC will engage in negotiations with a sufficient number of suppliers to ensure effective competition. The selection of the successful offer shall be based on the best and final offer that will be submitted on the specified date shown below, and which would meet the minimum technical specifications required.

4. Interested Bidders may obtain further information from *DILG R2* at the address given below during 8:00 AM to 5:00 PM during Monday to Friday excluding holidays.

- 6. The Pre-Bid Conference shall be open to all interested bidders. Bidders who wish to attend physically shall be required to observe health protocols, as follows:
  - Bidders should present vaccination cards;
  - Only two (2) representatives from each bidding agency are allowed in the conference hall;
  - · Proper wearing of mask at all times; and
  - Observe physical distancing.

The amount of not less than Twenty-Nine Thousand Pesos (P29,000.00), if bid security is in cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit. If in the form of a Surety Bond, submit also a certification issued by the Insurance Commission. The amount of not less than Seven-Two Thousand Five Hundred Pesos (P72, 500.00) if bid security is in Surety Bond;

#### or

Original copy of Notarized Bid Securing Declaration; and

(i) Compliance with the Schedule of Requirements (Annex I); and

- (j) Compliance with the Technical Specifications (Annex II); and
- (k) Original duly signed Omnibus Sworn Statement (OSS);

and if applicable, Original Notarized Secretary's Certificate in case of a corporation, partnership, or cooperative; or Original Special Power of Attorney of all members of the joint venture giving full power and authority to its officer to sign the OSS and do acts to represent the Bidder.

#### Financial Documents

- (1) The Supplier's audited financial statements, showing, among others, the Supplier's total and current assets and liabilities, stamped "received" by the BIR or its duly accredited and authorized institutions, for the preceding calendar year which should not be earlier than two (2) years from the date of bid submission; and
- (m) The prospective bidder's computation of Net Financial Contracting Capacity (NFCC);

#### or

A committed Line of Credit from a Universal or Commercial Bank in lieu of its NFCC computation.

#### Class "B" Documents

(n) If applicable, a duly signed joint venture agreement (JVA) in case the joint venture is already in existence;

duly notarized statements from all the potential joint venture partners stating that they will enter into and abide by the provisions of the JVA in the instance that the bid is successful.
