In addition, the Bidder shall submit two (2) copies of the first and second envelopes. In the event of any discrepancy between the original and the copies, the original shall prevail.
	Bidders shall enclose their original eligibility and technical documents described in ITB Clauses 10 and 11 in one sealed envelope marked "ORIGINAL-TECHNICAL COMPONENT", and the original of their financial component in another sealed envelope marked "ORIGINAL-FINANCIAL COMPONENT", sealing them all in an outer envelope marked "ORIGINAL BID".
	Each copy of the first and second envelopes shall be similarly sealed duly marking the inner envelopes as "COPY NO TECHNICAL COMPONENT" and "COPY NO – FINANCIAL COMPONENT"

	e. bear a warning "DO NOT OPEN BEFORE" the date and time	
	for the opening of bids, in accordance with ITB Clause 16	
	Bid envelopes that are not properly sealed and marked, as required	
	in the bidding documents, shall not be rejected, but the Bidder or its	
	duly authorized representative shall acknowledge such condition of	
	the bid as submitted. The BAC or the Procuring Entity shall assume	
	no responsibility for the misplacement of the contents of the	
	improperly sealed or marked bid, or for its premature opening.	
	If the bidder wishes to bid for all lots, the bidder shall prepare and
